### SOCIAL SECURITY CONTRIBUTIONS

Social Security contributions, or National Insurance contributions, are payable by both employees and employers under the National Insurance Act. Employers are required by law to pay contributions on behalf of all employees and unpaid apprentices. National Insurance is administered by the National Insurance Board and covers loss of earnings in the event of sickness, maternity, invalidity, injury on the job, retirement and death.

## HEALTH SURCHARGE IN TRINIDAD & TOBAGO

### Health Surcharge is payable

- By every employed person who pays or who is liable to pay contributions under the National Insurance Act
- By individuals other than self-employed persons who are liable to furnish a return of income.

### Those exempt from payment of the Health Surcharge are those:

- Under the age of 16
- 60 years and over
- Those whose only source of income is pension

### Health Surcharge is payable at 2 rates as follows:

- Where the monthly/weekly income is more than TT\$469.99 the rate is TT\$8.25 per week
- Where the monthly/weekly income is less than TT\$469.99 the rate is TT\$4.80 per week

These licenses are valid for 90 days while staying on the islands. Drivers are generally required to be 25 years and over and have had at least two years of driving experience. A major credit card is also required. Gas is not included in the price, and travellers are generally given unlimited mileage.

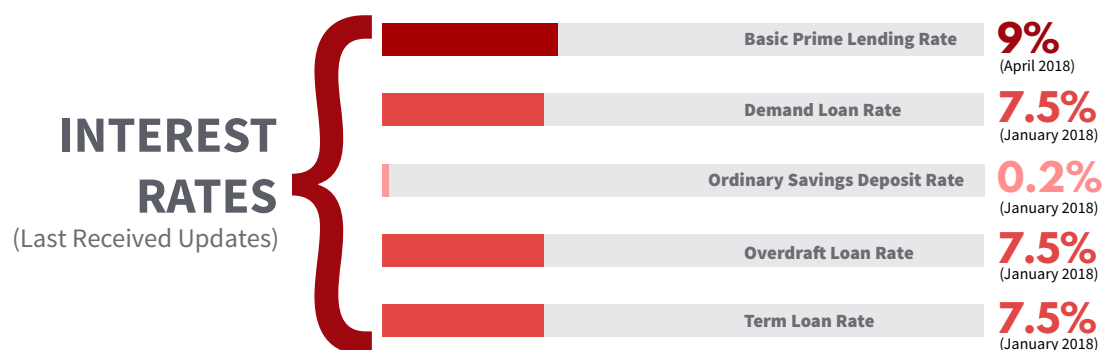
